PURPOSES AND GOALS

This course will trace the historical development of hymns in liturgical use, the scope of hymnic literature, and the major trends in hymnal compilation and editing. Course topics will include a survey of Western hymnody from its Latin roots to the contemporary American hymn. In addition, the course will compare/contrast all major denominational hymnals.

NOTEBOOK

At the time of the final exam, the student will be required to turn in a course notebook. This notebook should contain notes from all lectures, handouts, definitions, annotated bibliographies, etc. The format of the notebook is left up to the student, however, the purpose of the notebook is to serve as a resource for the future. List websites references and other pertinent information gained throughout the semester. **The notebook must contain an outline of the history of hymnody.**

PAPER

Each student will be required to submit one written analysis project. The paper will consist of a minimum of 2000 words. The paper may cover any topic relevant to the course. Topics might include an in-depth analysis of the hymns of a particular composer, the texts of a representative poet, a major trend in hymnody, etc.

PRESENTATION

Each student will be required to give an in-class presentation of no more than twenty (20) minutes. The presentation should serve to present research discovered in your written analysis project. The presentation may include power point presentation, recordings, overheads, live performance, handouts, etc. The presentation should not be a mere recitation of your paper . . . find a way to bring the topic and information to life!

HYMNAL ANALYSIS

Each student will provide a written analysis of their chosen hymnal. The analysis should include an historical survey of poetic texts and hymn tunes. The analysis will most likely be in an outline format. During the last week of classes each student will share their findings with colleagues.

EXAMS

Make-up exams will be given only under extraordinary circumstances.
