General Information

Description

Upon successful completion of this course, students will have advanced skills and knowledge of patterning, cutting, and construction techniques with a focus on theatrical tailoring. This will be accomplished through drafting, cutting, fitting, and construction of a suit coat for a specific individual. The coat completed will be of a masculine cut regardless of the gender identity of the model. Feminine tailoring requires expert fitting and construction techniques that are not at a level appropriate for this course. Advanced tailoring topics and techniques that will be covered include, but are not limited to: proportional drafting, direct measures, mockup construction and fitting, pattern alterations, considerations for the stage, slanted chest welt pocket, double welt pockets with flaps, lining pockets, pad stitching, upper collar construction, 2-piece sleeves, shoulder pads, sleeve headers, facings, linings, buttonholes, and buttons.

Expectations and Goals

This class is a 3 credit lecture class that meets for three periods, three times per week. Two class meetings will be reserved exclusively for lecture, demonstration, and review of materials. A third class meeting will be a supervised work period. Attendance is required for all periods and questions are encouraged during all. You should expect approximately 6-9 hours of additional homework outside of the scheduled class meeting time. Refer to the Course Schedule for due dates and the section on Evaluation of Grades for the grading metrics.

By the end of this course students will be able to understand and put into practice:

- The fundamentals of:
 - Taking measurements
 - Flat pattern drafting using direct and proportional measurements
 - Fitting a muslin mockup



- Flat pattern adjustments
- o Preparing fabric, materials, and notions
- Advanced tailoring construction techniques
- o Developing additional patterns for pockets, linings, and facings
