Course Description

3D asset production skills are essential for modelers and animators working in Communications, Film, Interaction Design, Game, Industrial Design, Augmented Reality (AR) and Virtual Reality (VR). This course instructs students in the best industry standard practices and pipelines for creating 3D assets, with a special concentration in producing content for Immersive environments.

Pre-Requisites

Enrollment in the MA in DAS program or consent of instructor.

Objectives: By the end of this course, students will be able to:

1. Produce Navigable AR/VR environments from concept to completion (Model, Texture, Shade, and Lighting).
2. Create Low-poly assets can be implemented into a Game Engine
3. Understand the 3D graphics pipeline (both pre and real-time rendered) and how it affects best practices for efficient and well-crafted 3D assets.
4. Manage and modify Physical Based Shader node.
