Overview

What is music heritage? How does music come to be recognized as heritage and who gets to decide? Who protects it, from what and for whom? This course will interrogate these questions and others by examining music heritage as a global process that connects music to the present, past, and future, and to critical issues of historic and cultural preservation. Cultural theorists argue that heritage is a modern phenomenon, a "mode of cultural production in the present that has recourse to the past" (Kirshenblatt-Gimblett 1995) and often aims to shape the future. As such, we will question what it means to think about heritage not as a noun but as a verb (Harvey 2001), adopting a dynamic focus related to human action and as an instrument of power. We will examine music heritage as a social, cultural, and political phenomenon that is, for many populations around the world, a vital source of identity shaped by history.

The course will unpack the development of the concept of intangible cultural heritage (ICH) as enshrined by UNESCO. Examining a range of case studies around the world, we will account for the different ways musical heritage and ICH have been defined and managed in national and international contexts and critically assess the problems and opportunities of attendant policies for musical communities. We will also approach music heritage from a local and grassroots perspective through the lens of musicians and cultural organizations. In doing so, we will study how diverse populations of various locations express their heritage and in turn, examine the diverse heritage of various locations.

By the end of this class, you will be able to:

- Understand and examine different conceptualizations of heritage and its relation to music.
- Drive discussion, undertake original research, and write about music that concerns processes

of heritage using descriptive and analytical techniques beyond those that you had before this course. This includes critically engaging with music through close reading, listening and research.

- Analyze and evaluate a range of arguments regarding the role of musical heritage in society, both generally and with respect to specific examples.
- Recognize and explain features of various musical artists, genres, and practices around the world and their engagement with concepts of heritage.

Assignments

1. Weekly Responses

Write a short response post on Canvas to the assigned class material by midnight on the day before class. Your response should demonstrate thoughtful engagement with all assigned material for a given class meeting. You may provide a critical response to the readings, place the readings in dialogue with one another and/or with content from prior class meetings, or compare the readings to your own research, listening, or performance experience. Responses will help structure class discussion.

2. Final Project

Conduct an original research project that relates to the themes of the course. You will submit a short proposal for your project consisting of an abstract and bibliography, present a 10-minute talk on your research project with a question-and-answer session, and complete a final paper. I will post more detailed guidelines on Canvas.
