### **Course Description**

This course includes independent dissertation research for PhD musicology and ethnomusicology students.

### **Course Objective**

- To engage in meaningful research activities within the fields of musicology and/or ethnomusicology.

### **Required Texts**

No textbooks or materials are required for the course, as each student will develop an individualized research plan with their instructor. Students are responsible for finding sources they need by using UF libraries to the fullest extent, as well as effectively using resources such as specialty libraries, credible online repositories, and archives. If students experience any trouble finding materials, or if they need letters of recommendation to access a library or archive, they should ask the instructor for assistance.

### **Course Schedule**

There is no set course schedule, as each student will develop an individualized research plan with their instructor.

### **Course Evaluation/Grading**

It is expected that written and verbal feedback from the instructor will help shape and/or improvements students' research as the semester progresses. It is also understood that goals/progress evaluation will not be the same for all students. Evaluation will be consistent with, and reflective of each student's ability level. Students may inquire about their progress at any point in the semester.

A Satisfactory grade will be awarded if:

- The student creates an individualized research plan, which is approved by the instructor.
- The student schedules and attends at least three meetings during the semester to discuss their research.

- The student clearly incorporates feedback and works to improve their research during the course of the semester.

An Unsatisfactory will be awarded if one or more of the following occurs:

- The student does not create an individualized research plan.
- The student does not schedule and attend at least three meetings during the semester to discuss their research.
- The student ignores feedback and their research stagnates during the course of the semester.
