This schedule of materials is designed to provide horn students with a comprehensive and well-rounded foundation in performance, preparing them for a wide range of musical situations. While each student has unique needs and interests, the structure is flexible enough to accommodate individual goals while maintaining a focus on developing a solid, fluid playing style supported by refined technique and expressive musicianship.

Class Meeting venue/time:

Lessons (one 50-minute period per week in MUB 352) are individually scheduled with the instructor. Horn Studio class meets on Thursdays at 12:50 p.m. (period 6) in MUB 120, January 15 – March 12. Attendance is required by all studio members. There will be 4 Brass Area Recitals this semester: Thursdays at 12:50 p.m. (period 6) in MUB 101, March 26, April 2, 9, and 16. Attendance is required by all studio members.

Attendance:

Students are expected to arrive on time for their lessons, fully warmed up and ready to play. A minimum of 7–14 hours of individual practice per week (outside of rehearsals) is essential for progress and success. Make-up lessons will be offered at the discretion of the instructor in cases of illness or university-related conflicts. Each unexcused absence from an individual lesson or studio class will result in a 1% deduction from the final grade. Class attendance, assignments, and other course requirements align with official university policies. Any questions regarding grading or these expectations should be directed to the instructor.

End of Semester Juries: Monday, April 27th, 8:30 a.m.- 12:00 p.m., MUB 101

A jury sign-up sheet will be provided as a fillable Google document and shared with each brass studio by their respective instructor. All students must bring one copy of the **Brass Area Jury Repertoire Form**, which includes basic student information, and a list of materials studied throughout the semester. Students are not required to provide copies of the music they will perform during the jury.

Regular juries are scheduled for 8 minutes total. This time includes the student entering the room, setting up, performing, and exiting. The student and their applied faculty member will decide in advance what repertoire will be performed. This may include etudes, exercises, orchestral excerpts, scales, and solo works (with or without piano accompaniment). Sight-reading may be included at the discretion of the instructor. Students who have performed a degree recital during the semester are generally not required to play a jury, but this is ultimately determined by the applied faculty member. Similarly, music minors are typically exempt from juries, but this too is up to faculty discretion.

Pre-Professional Juries, or PPJs, are typically presented at the end of the sophomore spring semester. Each jury is 16 minutes in total, which includes the time needed for the student to enter the room, set up, perform, and exit. Students will perform a solo work with piano accompaniment, not exceeding 8 minutes in duration. Alternatively, they may choose to perform a piece from the unaccompanied solo repertoire. After the performance, the student will give a 2 to 4-minute presentation on the piece, providing background on both the composer and the work itself. Reference notes may be used during the presentation. Sight-reading will be included at some point during the jury. Students are expected to dress in appropriate, professional attire. Please consult your studio instructor for additional guidance.

Horn Studio Conduct and Etiquette

General Informational Requests and Timely Response

If you receive a message from Dr. Basler about studio-related matters (via email, text, etc.), please do your best to reply in a timely manner. Prompt communication helps keep everything running smoothly!

E-mail Communication

It's a good habit to treat email as professional communication. All messages—whether to Dr. Basler or other faculty—should include a proper salutation (e.g., “Dear Dr. B,” “Hello, Dr. Basler,” “Good morning, Dr. B!”) and a closing (e.g., “Best, [Your Name],” “Have a great day! [Your Name],” “See you soon, [Your Name]”). The same applies to text messages—always begin with a brief greeting such as “Hi Dr. B!” or “Good morning, Dr. B!” to keep things respectful and courteous.

Lesson Illness Policy

Being part of a university community of over 60,000 people has its perks—but it also means you'll likely catch the infamous “Gainesville Crud” at some point. If you're feeling sick, please **do not** come to the studio for your lesson. Just send Dr. Basler a quick message (email, text, Facebook Messenger, etc.), and your lesson will be rescheduled for a later time.

1st Year (Freshman)

Concentration on basic technique and musicianship; all major and most minor scales throughout a two-octave range with consistent tone production and intonation throughout; development of a practice routine that specifically addresses problem areas; technical proficiency level of Kopprasch Book 1; solo studies from the standard repertoire; transposition exercises in commonly used keys.

2nd Year (Sophomore)

Continued concentration on technique; lip trills, multiple tonguing, flexibility and consistent tone production throughout a three-octave range; “singing” on the horn, continuing development of practice routine to achieve maximum results with minimum effort; technical proficiency of Kopprasch Book 2; solo studies from the standard repertoire; transposition exercises in commonly used keys.

3rd Year (Junior)

Refinement of technique; consistent tone production throughout a three and a half octave range at all dynamic levels; awareness of different tonal and articulation capabilities appropriate to various styles of music; finesse in phrasing appropriate to all styles, refining practice routine to achieve ease in playing; junior recital preparation and performance; technical level of Basler Etudes; orchestral, solo and chamber music studies from the standard repertoire.

4th Year (Senior)

Continued refinement of technique; elimination of problem areas, developing more strength, endurance, control, and expanding range up to four octaves; more finesse in musical expression; awareness of how to teach oneself; achieving ease in sight reading and transposition; extensive survey of horn repertoire; senior recital preparation and performance; technical level of Reynolds Etudes, Maxime-Alphonse Book 5; orchestral, chamber and solo works from the entire repertoire.

Graduate Performance Studies

Preparation for entrance into professional teaching and performance venues; advanced research on horn related issues, including appropriate instrument and mouthpiece selection and pedagogical materials; memorization of standard solo literature; performance in regional orchestras and at International Horn Society events; extensive survey of horn repertoire; graduate recital preparation and performance; technical level of Gallay Etudes, Maxime-Alphonse Book 6; orchestral, chamber and solo works from the entire repertoire.

The above is presented as a rough guideline for the course of study. The actual course of study will be tailored to each student's individual needs.

A student who publishes a recording without written consent may be subject to a civil cause of action instituted by a person injured by the publication and/or discipline under UF Regulation 4.040 Student Honor Code and Student Conduct Code.
